**TASK FORCE ON EMPLOYEE MISCLASSIFICATION  
MEETING MINUTES – OCTOBER 18, 2021**

**1. Call to Order and Roll Call.**

The meeting was called to order at 9:01 a.m. Roll Call and Quorum.

**2. Public Comment.**

There was no public comment.

**3. Election of Chair and Vice Chair.**

Nevada Revised Statutes (NRS) section 607.218 subdivision (7) requires the Task Force on Employee Misclassification to elect a Chair and Vice Chair at the first meeting of each fiscal year.

A motion was made by Ms. Grein to elect Teresa McKee, Chair, and Fran Almaraz, Vice-Chair, of the Task Force on Employee Misclassification. The motion was seconded by Mr. Benner and passed unanimously.

**4. Subcommittees and election/appointment of Subcommittee Chair(s) and/or Vice Chair(s).**

Nevada Revised Statutes (NRS) section 607.2195 provides the authority for the Task Force on Employee Misclassification to create Subcommittees.

The following Subcommittees were approved by the Task Force on Employee Misclassification last fiscal year: Agency Review and Policy Subcommittee and Legislative and Industry Subcommittee.

The members appointed to the Agency Review and Policy Subcommittee are: Chair McKee, Vice Chair Almaraz, Margi Grein, Rob Benner (Chair), and Alfonso Lopez.

The members appointed to the Legislative and Industry Subcommittee are: Chair McKee, Vice Chair Almaraz, Mary Beth Hartleb (Chair), Ashley Eddy Kott and Tom Burns.

A motion was made by Vice Chair Almaraz to approve the previous Subcommittees for this fiscal year along with the same appointment of members and Chairs to the Subcommittees. The motion was seconded by Chair McKee and the motion passed unanimously.
