Applications for the following IUOE Local 12 Apprenticeship Programs may ONLY BE PICKED UP on the 3rd Thursday of any month between the hours of 8:00 am and 4:30 pm:

- EQUIPMENT OPERATOR
- HEAVY DUTY REPAIRMAN
- MACHINIST
- SURVEYOR

- CONSTRUCTION SAFETY INSPECTOR
- RENEWABLE GREEN ENERGY INSPECTOR
- GENERAL CONSTRUCTION/BUILDING INSPECTOR

Complete applications may be returned by mail or in person any weekday during business hours.

Applicants will be notified by mail when test dates have been scheduled.

Applicants for the apprenticeship programs must meet the following requirements:

- 1. Legal resident of the U.S. no less than eighteen (18) years of age.
- 2. Survey and Machinist applicants must have educational background in Algebra and Geometry.
- 3. Must have a high school diploma <u>or</u> equivalent (i.e.: CHSE or GED) Acceptable substitute is a High School transcript showing <u>graduation date</u>.
- 4. Must have legal state-issued birth certificate Acceptable substitutions are U.S. Passport or proof of legal residency.
- 5. Veterans should provide copy of DD-214 or discharge papers.
- Proof of work experience, applicable to the specific program to which you are applying, may be presented (on company letterhead) detailing hours/years of equipment operated or work performed. Trade school certificates or letters may also be presented.

Note: Any submitted documents that are printed in a language other than English must be accompanied by a notarized English translation.
