AGENDA: The purpose of the workshop is to solicit comments from interested persons on NAC 608 and the following topics below related to potential additions, changes, and/or deletions to NAC 608 and any other proposed changes that may be submitted at the workshop or through written comments or testimony. Please submit written comments on or before Friday, November 14, 2025 at 4:00 PM.

1. NAC 608.100: "MINIMUM WAGE: APPLICABILITY; RATES; ANNUAL ADJUSTMENTS"— Amendment — Proposal of revisions to certain provisions of existing regulations concerning the minimum wage that were adopted before July 1, 2024. The purpose is to create consistency with the provisions of the Nevada Constitution, which states that an employee in the State of Nevada is not less than \$12 per hour worked whether the employee is a full time, permanent, part-time, probationary or temporary employee.

- 2. NAC 608.120: "PAYMENT of COMMISSIONS" Amendment Proposal of procedural system which permits an employee to file a complaint or claim with the Labor Commissioner for the payment of commissions owed, the employee is required to submit a written request to the employer for the payment of commissions owned. The amendment also emphasizes that an employer is given fifteen (15) days to respond to the request for payment of commissions owned.
- 3. NAC 608.102, 608.104, 608.106, 608.108, and 608.123: VARIOUS MINIMUM WAGE REGULATIONS RELATING to HEALTH INSURANCE and COMPENSATION Repeal Proposal to repeal certain obsolete regulations that were adopted before July 1, 2024, which set out certain requirements and restrictions concerning the minimum wage a private employer is required to pay an employee per hour worked based upon whether the employer provides certain health benefits to the employee.
